Introduction

The following document constitutes Annex 4 of the report "1.1 Billion euros, 63 Projects, Six Countries, One Pattern: How EU funds violate fundamental rights". It provides an overview of project examples, in some cases these are call for proposals, collected as part of the FURI project in Czechia, Romania, Bulgaria, Greece, Poland and Hungary.

It total, the research documented 63 project examples involving an estimated total value of approximately 1.1 billion euros. The original project values are in the national currencies. An estimate in EU is also provided, calculated based on the exchange rate in May 2025.

Each example has been summarised for brevity, presenting with the following information:

- Locality concerned;
- Short description of the project;
- Explanation of the rights violation at stake;
- Total project cost;
- Explanations on actions taken, if any;
- Project/call for proposals reference number.

These examples address issues such as educational and housing segregation, institutionalisation, the reception of asylum seekers, and migration control (e.g. pushbacks).

The pictures included in the report come either directly from the project partners or from a variety of publicly available sources, such as websites from the managing authorities, google maps, and project beneficiaries' websites.

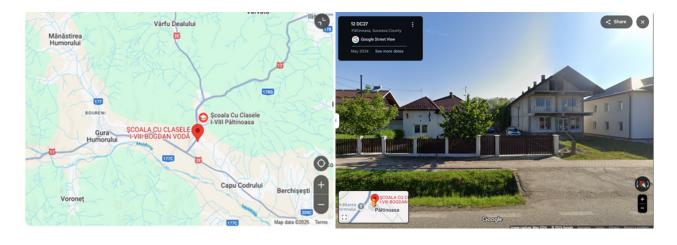

Education segregation

PROJECT 1 - ROMANIA, SUCEAVA COUNTY

Location	Păltinoasa Gymnasium School, Suceava County, Romania
Description	Forty-four Roma students were relocated to the school's sports hall, a separate building from the main school where the majority of students are taught. The sports hall is inadequately heated during winter and lacks direct access to sanitary facilities. The 44 students (from preparatory classes to grade 4) were placed in two classes and taught simultaneously.
Rights violated	Segregated education of Roma students based on ethnic and socio-economic criteria. • Art 21, Charter
Funding	Total project budget: 1,261,000 lei [247,254 EUR], ESF
Actions taken	The National Council for Combating Discrimination (CNCD) <u>confirmed</u> that an act of school segregation had indeed occurred: "The problem is segregation on ethnic grounds. That is, 99% of the Roma children from that village were relocated." Consequently, on 2 October 2024, the CNCD decided to fine Păltinoasa Gymnasium School in Suceava County 5,000 lei, and the Suceava County School Inspectorate 3,000 lei for segregating 44 Roma students.

PROJECT 2 ROMANIA, VÂLCEA COUNTY

Location	"Luca Solomon" Gymnasium School, Vaideeni, Vâlcea County, Romania
Description	The project aimed to prevent school dropout and reduce early school leaving among students. The expected outcomes included improved academic performance, more positive attitudes, and increased openness towards school in general. However, the project involved the creation and operation of separate classes at the gymnasium level specifically for Roma students.
Rights violated	Segregated education of Roma students based on ethnic and socio-economic criteria. • Art 21, Charter
Funding	Total project budget: 900,226 lei [176,514 EUR], RRF
Actions taken	According to the <u>decision of the CNCD</u> (Hotararea nr. 438, din 30.08.2023), the Gymnasium School in Vaideeni, Vâlcea County, was fined for segregation after dividing students into classes based on their ethnicity and place of residence. The fine, in the amount of 2,000 lei, creating separate classes based on ethnicity and place of residence.

PROJECT 3 ROMANIA, IASI COUNTY

Location	Dăgâța, Iași County, Romania
Description	Two projects were aimed at preventing school dropout and reduce early school leaving among students. The expected outcomes were improving academic results, attitudes, and openness toward school in general. However, the projects involved the creation and operation of separate classes at the gymnasium level specifically for Roma students.
Rights violated	Segregated education of Roma students based on ethnic and socio-economic criteria. • Art 21, Charter
Funding	Total project budget: 5,279,000 lei [1,035,098 EUR], ESF
Actions taken	According to the <u>decision</u> of the CNCD (Hotararea nr. 504 din 17.06.2020), based on Art. 2 Para. 1, Art. 2 Para. (4), Art. 11 Para. 1, and Art. 15 of O.G. 137/2000, are present, and the defendant will be fined 2,000 lei, while the laşi County School Inspectorate will be fined 4,000 lei. Additionally, the defendant is required to take the necessary steps to ensure that the school has and implements an effective desegregation plan".

PROJECT 4 ROMANIA, IASI COUNTY

Location	"Titu Maiorescu" Secondary School, Iași, Romania
Description	The "Şcoala DA" project aimed to increase access to education and promote social inclusion for 430 children, including 105 of Roma ethnicity and 60 from rural areas, by providing an integrated package of psycho-social and educational services, as well as developing professional skills among 240 teachers. Despite being enrolled at Titu Maiorescu School in laşi, 122 Roma students were transferred to Ion Neculce Secondary School in laşi, which is known for ranking among the lowest compared to other educational institutions.
Rights violated	Segregated education of Roma students based on ethnic and socio-economic criteria. • Art 21, Charter
Funding	Total project budget: 3,584,503 lei [702,843 EUR], ESF
Actions taken	The PRO EUROPA Roma Party Association filed a complaint, which was subsequently withdrawn. Following the withdrawal, the CNCD (<u>Hotararea nr. 172</u>) closed the case. At the same time, the Head of the CNCD, Csaba Asztalos, <u>stated</u> : 'We need to discuss how we reached a point where 80% of the students are of Roma ethnicity'.

PROJECT 5 HUNGARY, SZOLNOK COUNTY

Location	Szolnok county, Hungary
Description	The main objective of the project was complex and targeted support for broad spectrum of public education institutions, from kindergarten to secondary school. It included the development of a system of professional educational services at regional and local level. The project aimed to reduce early school leaving, segregated education, underperforming in national competency tests.
Rights violated	The program, one of the largest EU-funded educational initiatives targeting early school leaving (ESL) and disadvantaged students, failed to address fundamental rights violations, particularly segregation. According to the evaluation of the project , the level of segregation remained intact or even slightly increased during the program. • Art 14, 21, Charter

PROJECT 6 BULGARIA, BRATYA DASKALOVI

Location	Bratya Daskalovi, Bulgaria
Description	The project 'Ready for Success' aims to address the integration of Roma communities in the education system, especially in small settlements. It tackles isolation, prevents early dropout, and reduces future labour market exclusion. The project includes activities such as assessing children's attitudes, identifying contributing factors, and understanding parental expectations; providing supplementary Bulgarian language classes; and organising extracurricular activities.
Rights violated	The project includes investments in the segregated area, which leads to further segregation. The project primarily focuses on behavioral correction and attitude change in Roma communities, which justifies that the underlying assumption is flawed. This approach not only fails to address broader issues of poverty and spatial segregation but also neglects the deeper, systemic factors contributing to educational disparities. Excerpt from the municipality's development plan reveals a tendency to blame the minority community, showcasing discriminatory attitudes rather than exploring underlying systemic problems. The plan's explanation for school dropout rates, while mentioning economic factors and migration, disproportionately focuses on "cultural practices" within the Roma community, with negative tone.

PROJECT 7 BULGARIA, TUNDZHA

Location	Tundzha, Bulgaria
Description	The project covers all 44 rural settlements in Tunja municipality, it focuses on areas with concentrated Roma populations and marginalized groups. It will provide key interventions include improving access to employment, education, health, and social services". It also focuses on the education of the Roma children.
Rights violated	The project fails to address the root problem of educational segregation. Although employing educational mediators (10 in total) is a valuable practice with demonstrable positive outcomes, their impact is limited. The projects fail to address broader issues of poverty and spatial segregation, which significantly limit Roma children's access to quality education. The project also focuses on behavioural correction and attitude change of Roma communities, it implies that the problem lies within the Roma community itself, rather than addressing the systemic factors contributing to educational disparities. • Art. 14, 21, the Charter of Fundamental Rights

PROJECT 8 CZECHIA, OSTRAVA

Location	Ostrava, Czechia
Description	Between 2016 and 2020, approximately €10 million was allocated to the project Equal Access for Romani and Socially Disadvantaged Children. While the project's stated goal was to ensure equal access to quality education, its outcomes were misaligned with this objective. Instead of promoting inclusion, the project contributed to the further segregation of Roma communities. Notably, both the number of segregated Romani children and school dropouts increased during this period.
Rights violated	This ongoing segregation highlights serious failures in ensuring that EU funding complies with the EU's anti-discrimination framework. Monitoring and enforcement mechanisms proved inadequate, allowing this misuse of funds to continue unchecked. Compounding the problem, some municipal officials openly denied the existence of segregated schools, despite clear evidence. This institutional denial obstructed meaningful reform, made it nearly impossible to reallocate resources effectively, and prevented accountability for the misuse of EU funds.

Location	Territory of Greece
Description	Effective inclusion of pupils with disabilities and/or special educational needs in education; the reduction of school failure and drop-outs; the smoother integration of pupils with special educational needs into the education system, and ultimately the improvement social cohesion.
Rights violated	EU funds support contributes to the expansion of Special Schools and Special Vocational Education and Training Workshops (SVETWs), which may risk perpetuating segregation, in possible breach of the rights of children with disabilities. • Articles 1, 3, 5, 24, 26 Charter, • Article 24 UN CRPD
Funding	Total project budget: 193,254,981.32 EUR, ESF+

Education segregation and institutionalisation

PROJECT 10 - CZECHIA, OSTRAVA

Location	Several localities, Czechia
Description	A "Children's House" (residential childcare institution) is attached to primary school Na Vizine in Ostrava (https://www.domov-vizina.cz/). Most children in the facility are Roma. The school applied to European funds, presenting itself as an educational project. Another fifteen cases have been explores by a study (please insert reference) across the Czechia, where residential childcare institutions are administratively linked to segregated schools. Analysis of OP VVV programs in Olomouc, Ivancice, and Hamry na Jezere found similar administrative structures.
Rights violated	Such an arrangement reinforces segregation and impedes the transition to community-based services, family life. Furthermore, it also strongly limits Roma children' educational choices and perpetuating barriers to social inclusion. NGOs and experts have expressed concern that these administrative units benefit from EU funds under the objective banner of "educational support," while deliberately reinforcing institutional care. • Art. 21 Charter

PROJECT 11 - POLAND, LODZ

Location	Lodz, Poland
Description	Innovative residential social care home for people with mental disorders. Transformation of the support system for people with psychosocial disabilities, renovation of the building
Rights violated	Institutionalisation of people with psychosocial disabilities, the facility is architecturally and functionally separated from the community. Lack of any measures to facilitate leaving the facility and living in an individual home. No choice provided to use of services in institutions/residential facilities or those provided at the community level. Limited opportunities provided for choice and independent living. Sharing assistants, and lack of control over daily decisions. • Art 21 Charter • Art 19 UN CRPD.
Funding	Total project budget: 9,635,879 PLN [2,272,613 EUR], ERDF
Actions taken	A <u>complaint</u> was sent by ENIL and Validity Foundation to the managing authority and the European Commission. The response did not recognise the fundamental rights violations, no action was taken by the responsible authorities. The European Commission has promised a separate response to the complaint, but the follow-up is unknown and the investment was made.

Description	Extension and reconstruction of the Adult Social Care Home building
Rights violated	Institutionalisation of elderly, people with disabilities. Lack of any measures to facilitate leaving the facility and living in an individual home. No choice provided to use of services in institutions/residential facilities or those provided at the community level. Limited opportunities provided for choice and independent living. Sharing assistants, and lack of control over daily decisions. • Art 21 Charter • Art 19 UN CRPD
Funding	Total project budget: 11,450,776 PLN [2,700,654 EUR], ERDF
Actions taken	A complaint was sent by ENIL and Validity Foundation to the managing authority and the European Commission. The <u>response</u> did not recognise the fundamental rights violations, no action was taken by the responsible authorities.

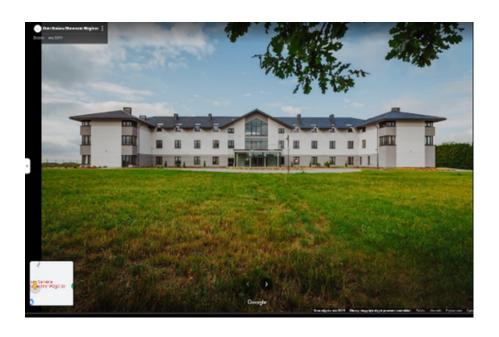

Rights violated	Institutionalisation of elderly, people with disabilities. Lack of any measures to facilitate leaving the facility and living in an individual home. No choice provided to use of services in institutions/residential facilities or those provided at the community level. Limited opportunities provided for choice and independent living. Sharing assistants, and lack of control over daily decisions. • Art 21 Charter • Art 19 UN CRPD

The Ombudsman's inquiry identified issues with how the Commission has complied with its duty to ensure the MPRICs comply with fundamental rights standards. Given the concerns, including with regard to the detention-like nature of the facilities in MPRICs, the Ombudsman suggested that the Commission carry out a fundamental rights impact assessment of the centres, with a view to identifying measures to mitigate any potential risks. The Commission should then publish this assessment.
